Overview

Forty-six home health agencies responded to the 2020 survey: 36 free-standing and 8 hospital-based.

Table 1 shows that 78% of home health agencies reported for-profit status. Approximately 52% of the agencies were controlled by corporations, 15% were controlled by local government and the remaining 33% were controlled by other entities. There were not any home health agencies controlled by state government.

Referrals by type of home health agency are shown in Table 2. Of the 119,432 total referrals, 95,881 or 84% were accepted. Reasons for denied service are shown in Table 2. Besides the category “other”, the “not meeting home health service eligibility” group was the main reason patients were denied service. Most referrals, 88%, were from physicians and hospitals.

For this report, data from hospital-based home health agencies are shown in tables ending in an A, free-standing home health agencies are shown in tables ending in a B, and tables ending in a C represent state totals. Some tables without letters A, B or C provide all three totals referenced above in one table.

Patients Served

Based on Table 2, there were 94,280 patients served during 2020. This is a non-duplicate (unduplicated) count of people. Total number of patients served during 2015 was 89,410.

Table 3 shows type of services provided by home health agencies. Skilled nursing, home health aides, physical therapy and speech/audio are provided by all home health agencies. Forty-three agencies provided social services, twenty-five agencies provided nutrition and four agencies provided respiratory therapy. Appliance/equipment data is no longer being captured.

Table 4 shows home health patients served by source of payment. Most patients, 75,074 or 65.8% were covered by Medicare, followed by 33,766 or 29.6% by private insurance. Three thousand, five hundred ninety-seven were covered by Medicaid. The remaining 1,632 patients were covered by self-pay or charity/other.

Tables 5 display the number of patients served by agency during calendar year 2020 by source of payment.

Tables 6 display the number of patients served by county by agency during calendar year 2020.

Table 7 displays the number of patients served during calendar year 2020 by type of services provided.

Patients served during calendar year 2020 by type of service provided by county may be found in Tables 8.

Table 9 shows home health patients served by Districts/Regions. Region 2 served the most patients (unduplicated count), 40,123 or 35.2%, followed by Region 3 with 35,284 or 31.0% and Region 1 with 34,223 or 30.0%.

Home health patients served during calendar years 2010-2020 by type of service are shown in Table 10. Patients served increased from 104,455 in 2010 to 123,291 in 2015 and decreased to 114,070 in 2020.

Historical home health patients served and visits during calendar years 1985 - 2014 by type of services provided may be found in Table 1 and Table 2 on the Mississippi State Department of Health website (www.msdh.ms.gov).

Visits

Table 11 displays home health agency visits by source of payment. Most visits, 1,758,138 or 74.2%, were paid by Medicare, followed by private insurance which paid for 555,633 or 23.5%. Medicaid, self-pay and charity/other made up the other 2.3%.

Home health agency visits by agency during calendar year 2015 by source of payment may be found in Table 12.

Home Health Agency visits by agency may be found in Table 13. Table 14 shows number of patient visits by type of service.

County data is shown in Table 15. Skilled nursing visits accounted for 54.0% of the 120,564 visits. Home health aide visits comprised 5.42% and physical therapy 29.2%. Social services, speech/audio, occupational therapy, nutrition, and respiratory therapy services made up the other 274,252 visits.

Table 16 shows home health visits by home health regions. Region 2 reported the most visits with 928,331, followed by Region 3 with 738,448, and Region 1 with 701,433.

Total home health agency visits during calendar years 2010-2020 are shown in Table 17. Home health agency visits decreased from 3,474,371 in 2010 to 2,623,784 in 2015 and further decreased to 2,368,252 visits in 2020.

Home health agency admissions by agency by county are reported in Table 18.

Total home health agency patient census slightly increased in 2020. Table 19 shows that the beginning census was 26,650 and ending census was 27,037.

Employee data are shown in Table 20. Nurses and aides constitute the largest group of employees, 1,506 or 53.2% of the total. Home health employees decreased from 3,135 in 2015 to 2,826 in 2020.

There is a list of home health agencies by classification by county in Appendix A. Counties served by each agency are indicated.

A copy of the instructions and the 2020 Annual Report (survey instrument) may be found in Appendix B.

Definitions

Branch Office shall mean a location or site from which a home health agency provides services within a portion of the total geographic area served by the parent agency. The branch office is part of the home health agency and is located sufficiently close (within a fifty (50) mile radius) to share administration, supervision and services in a manner that renders it unnecessary to obtain a separate license as a home health agency. A branch office shall be staffed with at least one (1) registered nurse on a full-time basis.

Directly shall mean providing home health services through salaried employees of the home health agency or through personnel under hourly or per visit contracts or the equivalent. Where an hourly or per visit contract is made, Part V Section H must be followed to ensure adequate control and supervision by the home health agency.

Geographic Area shall mean the land area, for which the agency shall be licensed, consisting of not more than a fifty (50) mile radius surrounding the home health agency's office location. The geographic area shall be expressed in Mississippi counties.

Home Health Agency shall mean a public or privately owned agency or organization, or a subdivision of such an agency or organization, properly authorized to conduct business in Mississippi, which is primarily engaged in providing to individuals at the written direction of a licensed physician, in the individual's place of residence, skilled nursing services provided by or under the supervision of a Registered Nurse licensed to practice in Mississippi, and one or more of the following part-time or intermittent services or items:

- a. physical, occupational or speech therapy
- b. medical social services
- c. home health aide services
- d. other services as approved by the licensing agency
- e. medical supplies, other than drugs and biologicals, and the use of medical appliances
- f. medical services provided by a resident in training at a hospital under a teaching program of such hospital.

Parent Home Health Agency shall mean the agency that develops and maintains administrative control of sub-units and/or branches.

Patient's Residence shall mean the place where the patient makes his home, such as his own apartment or house, a relative's home but shall not include a hospital, nursing home or other extended care facility with the exception of services provided through outpatient therapy in a nursing home.

Skilled Nursing Services shall mean patient care services pertaining to the curative, restorative, and preventive aspects of nursing performed by or under the supervision of a registered nurse pursuant to the plan of treatment established in consultation with appropriate members of the care team. Skilled nursing service is nursing care emphasizing a high level of nursing direction, observation, and skill.

Sub-Unit shall mean a semi-autonomous organization which serves patients in a geographic area different from that of the parent agency. A sub-unit shall be licensed separately from the parent agency and shall not have a branch office.
