Our goal is and always has been, to provide to you a safe and dependable supply of drinking water. Our water source is *the Graham Ferry Formation aquifer. The vulnerability assessment report from the DEQ shows our "old" well as moderate, but has not yet been completed for the new well. This report is available at the office.* I'm pleased to report that our drinking water meets all federal and state requirements. This table shows the results of our monitoring for the period of 01/01/08-12/31/08.

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

These substances can be microbes, inorganic or organic chemicals and radioactive substances. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. A Message From MSDH Concerning Radiological Sampling

In accordance with the Radionuclides Rule, all community public water supplies were required to sample quarterly for radionuclides beginning January 2007 – December, 2007. Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Mississippi State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice. Although this was not the result of inaction by the public water supply, MSDH was required to issue a violation. The Bureau of Public Water Supply is taking action to resolve this issue as quickly as possible. Violations and Exceedances

Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially harmful bacteria may be present. We monitor your water for coliforms by taking monthly samples. An audit of the Mississippi State Department of Health revealed that this monthly sample was not taken during February, 2005, resulting in our system receiving a violation, although no problems were found with your drinking water. All required samples have been taken since then with no further violations.

All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk. We ask that all our customers help us protect our water sources, which are the heart of our community, our way of life and our children's future.

***Violations and Exceedances**

We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standard. Beginning January 1, 2004, the Mississippi State Department of Health (MSDH) required public water systems that use chlorine as a primary disinfectant to monitor/test for chlorine residuals as required by the Stage 1 Disinfection By-Products Rule. Our water system failed to complete these monitoring requirements in February of 2005. We did complete the monitoring requirements for bacteriological sampling that showed no coliform present. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk. We ask that all our customers help us protect our water sources, which are the heart of our community, our way of life and our children's future.
