The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Town of Tremont have received a **moderate** ranking to contaminations.

Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Ms. State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice.

Although this was not the result of inaction by the public water supply, MSHD was required to issue a violation. The Bureau of Public Water Supply is taking action to resolve this issue as quickly as possible. 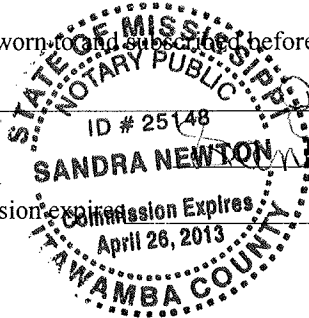
