



CITY OF ROLLING FORK ANNUAL DRINKING WATER QUALITY REPORT PWS ID# 0630004

The City of Rolling Fork wants to keep you informed about the water and services we deliver to you. For this very reason, we are pleased to provide you with this year's annual water quality report. Our goal is and has always been to provide you a safe, adequate, and dependable supply of drinking water. We at the City of Rolling Fork work hard to provide safe, quality water to every tap on the system. We ask that all our customers help us protect our water sources, which are the heart of our community, our way of life, and our children's future.

Our water source consists of three wells pumping from the Sparta Sand Aquifer System. Last year, we conducted tests for many contaminants, detecting only 6, none of which exceeded drinking water standards. As we informed you earlier this year, our water system violated a drinking water standard by failing to sample for **LEAD/COPPER** for the sample period ending 12/31/2008. (For more information see the title **Violations and Exceedances** at the end of this report).

Our source water assessment is complete. As required by the Safe Drinking Water Act, copies of the source water assessment and of this CRQ report are available upon request at City Hall. We want you to be informed about your water and our City. If you want to learn more, please attend any of the City Board meetings. They are held on the first and third Tuesdays of each month, starting at 4:00 pm at City Hall. Educational Information

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as people with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Water Drinking Hotline (800-426-4791).

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline (800-426-4791). The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife, inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm-water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm-water runoff, and residential use; organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production; and radionuclides, which can come from natural gas production and refining activities, and can also come from gas stations, urban storm-water runoff, and septic systems, and radionuclides, which can be naturally occurring or be the result of oil and gas production and refining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

The table below lists all of the drinking water contaminants that we detected for the period of January 1st to December 31st, 2008. The presence of contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of the data, though representative of the water quality, may be more than one year old. In this table you will find terms and abbreviations you might not be familiar with. To better understand these we've provided the following definitions:

- MCL-Maximum Contaminant Level Goal:** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- MCL-Maximum Contaminant Level:** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- AL-Action Level:** The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.
- MIDL-Maximum Residual Disinfection Level Goal:** The level of a drinking water disinfectant below which there is no known or expected risk to health. MIDLs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- MIDL-Maximum Residual Disinfection Level:** The highest level of a disinfectant allowed in drinking water. There is supporting evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- PbP- Parts per million or milligrams per liter (mg/L)**
- PPb- Parts per billion or micrograms per liter (µg/L)**

****Additional information for Lead - If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. SouthWest Water Company is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Violations and Exceedances

*******A MESSAGE FROM MSDH CONCERNING RADIOLOGICAL SAMPLING*******
 In accordance with the Radionuclides Rule, all community public water supplies were required to sample quarterly for radionuclides beginning January 2007 - December 2007. Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Mississippi State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice. Although this was not the result of inaction by the public water supply, MSDH was required to issue a violation. The Bureau of Public Water Supply is taking action to resolve this issue as quickly as possible. We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. For the sample period ending 12/31/2008 we did not monitor for LEAD/COPPER and therefore cannot be sure of the quality of our drinking water received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

There is nothing you need to do at this time regarding the LEAD/COPPER violation. LEAD/COPPER sampling is performed on a triennial basis. As we informed you at the time, follow-up samples are scheduled to be taken by the end of June of 2009. Although this is not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this violation.
