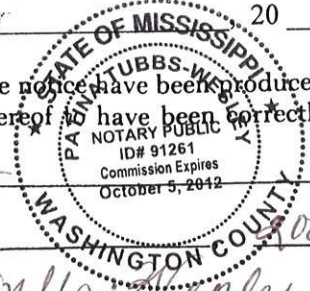

Make it a family effort to reduce next month's water bill!
