We're pleased to present to you the year's Annual Water Quality Report. This report is designed to inform you about the quality of your water and to help you understand the efforts we make to consistently improve the water treatment process and protect water resources. We are committed to ensuring the quality of your water. The Talking Warrior Water Assn. is supplied by groundwater pumped from 8 wells, each about 1400 feet deep in the Grotto aquifer. These wells are used on Williams Road. Our Ground Water Assessment is currently being conducted and is not available at the time. As soon as it is completed, you will be notified and copies of this assessment will be available at our office. We are proud to report that the water provided by Talking Warrior Water Assn. meets or exceeds established water quality standards.

If you have any questions about this report or concerning your water utility, please contact Joe Williams at 324-4222. We want our valued customers to be informed about their water supply. If you want to learn more, please attend any of our monthly scheduled meetings. They are held on the 1st Tuesday of each month, under the water tower, on Williams Road.

Talking Warrior Water Assn. routinely analyzes for contaminants in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st, 2009. As water travels over the land or underground, it can pick up substances or contaminants such as microbials, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. It is important to remember that the presence of these contaminants does not necessarily pose a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Maximum Contaminant Level: Maximum allowable concentration for the contaminant in tap water.
Maximum Contaminant Level Goal: Maximum allowable concentration for the contaminant in tap water. It is not enforceable.
Contaminant: Any substance that is not naturally occurring in water and is not expected to be in the water.
