We're very pleased to provide you with this year's Annual Water Quality Report. We want to keep you informed about the excellent water and services we have delivered to you over the past year. Our constant goal is and always has been, to provide you a safe and dependable supply of drinking water. Our water source is five wells. Our wells draw from the Coffee Aquifer.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. The general susceptibility rankings assigned to each well of this system are provided immediately below. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. Our wells received a moderate susceptibility to contamination.

I'm pleased to report that our drinking water meets all federal and state requirements.

If you have any questions about this report or concerning your water utility, please contact Doug Norton at (662) 685-4721. We want our valued customers to be informed about their water utility. If you want to learn more, please attend our scheduled meetings. They are held on the first Thursday of each month at 6:00 P.M. The meetings will be conducted at the City Hall.

The Town of Blue Mountain routinely monitors for constituents in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st, 2008. As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Action Level-the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

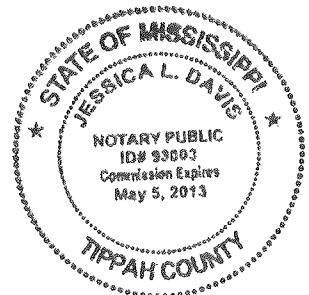
