**Microbiological Contaminants:**

(1) Total Coliform. Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. Coliforms were found in more samples than allowed and this was a warning of potential problems.

As you can see by the table, our system violated a drinking water standard. In January of 2009, we took 3 samples, all three showed the presence of coliform bacteria. The water line operating the chlorine equipment was frozen, not allowing chlorine to be added to the water. The distribution system has been disinfected and additional samples did not show presence of coliform bacteria.

We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During April 2010 we did not complete all monitoring or testing for bacteriological and chlorine and therefore cannot be sure of the quality of our drinking water during that time. During this time we were required to pull 5 samples and only pulled 3. Normally we pull 3 samples per month. After we had one to be contaminated by rain, the following month we should have pulled 2 extra samples. We forgot to pull the two extra samples that were required.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers.
