Our water source is from wells drawing from the Cockfield Formation and Sparta Aquifers.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. The general susceptibility rankings assigned to each well of this system are provided immediately below. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Monterey Water Association, Inc. have received a moderate susceptibility ranking to contamination.

We routinely monitor for constituents in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that we detected during for the period of January 1st to December 31st, 2010. In cases where monitoring wasn't required in 2010, the table reflects the most recent results. 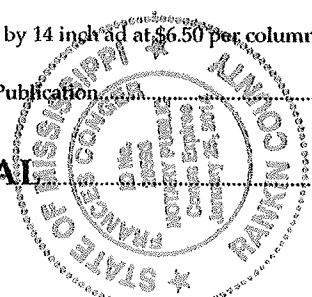

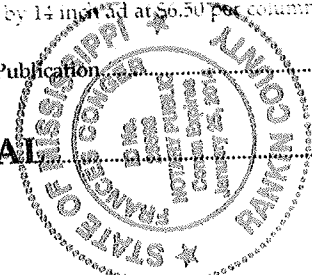
