The sources of drinking water (both tap water & bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, & wells. ### Water Conservation Tips

Did you know that the average U.S. household uses approximately 400 gallons of water per day or 100 gallons per person per day? Luckily, there are many low-cost & no-cost ways to conserve water. Small changes can make a big difference – try one today & soon it will become second nature.

- Take short showers - a 5 minute shower uses 4 to 5 gallons of water compared to up to 50 gallons for a bath.
- Shut off water while brushing your teeth, washing your hair & shaving & save up to 500 gallons a month.
- Use a water-efficient showerhead. They're inexpensive, easy to install, & can save you up to 750 gallons a month.
- Run your clothes washer & dishwasher only when they are full. You can save up to 1,000 gallons a month.
- Water plants only when necessary.
- Fix leaky toilets & faucets. Faucet washers are inexpensive & take only a few minutes to replace. To check your toilet for a leak, place a few drops of food coloring in the tank & wait. 

Term	Definition
MCLG	MCLG: Maximum Contaminant Level Goal. The level of a contaminant in drinking water below which there is no expected risk to health. MCLGs allow for a margin of safety.
MCL	MCL: Maximum Contaminant Level. The highest level of a contaminant that is allowed in drinking water. MCLs are close to the MCLGs as feasible using the best available treatment technology.
TT	TT: Treatment Technique. A required process intended to reduce the level of a contaminant in drinking water.
AL	AL: Action Level. The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
Variances & Exemptions	Variances & Exemptions: State or EPA permission not to meet an MCL or a treatment technique under certain circumstances.
MRDLG	MRDLG: Maximum residual disinfectant level goal. The level of a drinking water disinfectant below which there is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
MRDL	MRDL: Maximum residual disinfectant level. The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
MNR	MNR: Monitored Not Regulated
MFL	MFL: State Assigned Maximum Permissible Level
