The wells for the New Providence Water Association have received lower susceptibility rankings to contamination.

We routinely monitor for constituents in your drinking water according to Federal and State laws. In cases where monitoring wasn't required in 2010, the table reflects the most recent results. Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control microbial contaminants.

Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.
