We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. We did complete the monitoring requirements for bacteriological sampling that showed no coliform present. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. 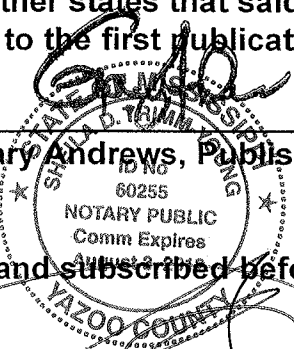

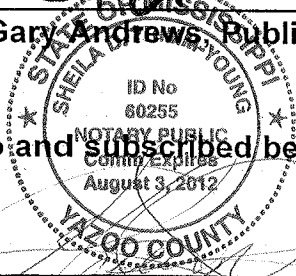

TO COMPLY WITH THE REGULATION GOVERNING FLUORIDATION OF COMMUNITY WATER SUPPLIES, THE HILTON HEIGHTS WATER ASSOCIATION #1 IS REQUIRED TO REPORT CERTAIN RESULTS PERTAINING TO FLUORIDATION OF OUR WATER. THE NUMBER OF MONTHS IN THE PREVIOUS CALENDAR YEAR THAT AVERAGE FLUORIDE SAMPLE RESULTS WERE WITHIN THE OPTIMAL RANGE OF 0.7-1.3 PPM WAS 12. THE PERCENTAGE OF FLUORIDE SAMPLES COLLECTED IN THE PREVIOUS CALENDAR YEAR THAT WAS WITHIN THE OPTIMAL RANGE OF 0.7-1.3 PPM WAS 100%.
