We're pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. We purchase our water from the Town of Woodville which pumps it's water from the Miocene Aquifer. A source water assessment has been conducted and is available at the Woodville Town Hall. If you have any questions about this report or concerning your water utility, please contact Paul Thimmesch at (601)888-3782. We want our valued customers to be informed about their water utility. This report is not required to be delivered by mail. Copies are available at our office. If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the second Monday of each month, at 4:30 pm, at our office in Woodville. The Old River Water Association – Ford’s Creek routinely monitors for constituents in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st, 2010. As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Action Level - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Treatment Technique (TT) - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

Maximum Contaminant Level - The “Maximum Allowed” (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal - The “Goal”(MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses, and parasites, which can cause symptoms such as nausea, cramps, diarrhea, and associated headaches.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Old River Water Association is responsible for providing high quality drinking water, but cannot control the variety of components used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. Information on lead and drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>. Significant Deficiencies

During a sanitary survey conducted on 1/19/2010, the Mississippi State Department of Health cited the following significant deficiencies:

1.) Inadequate application of treatment chemicals and techniques (Primary MCLs)

Corrective actions: The system has installed a new lime feeder and repaired one of the old lime feeders. All deficiencies are scheduled to be completed by 2/9/2011.

2.) Failure to meet water supply demands (overloaded)

Corrective actions: The system is currently under a Bilateral Compliance Agreement with the Mississippi State Department of Health to increase the source capacity of the system. All deficiencies are scheduled to be completed by 8/31/2011.

3.) Lack of redundant mechanical components where treatment is required

Corrective actions: The system is currently under a Bilateral Compliance Agreement with the Mississippi State Department of Health to install redundant chlorination and upgrade the filtration system. All deficiencies are scheduled to be completed by 8/31/2011

All sources of drinking water are subject to potential contamination by substances that are naturally occurring or man made. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants.
