Our water source is from wells drawing from the Meridian Upper Wilcox Aquifer.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. The general susceptibility rankings assigned to each well of this system are provided immediately below. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Town of Drew have received a lower susceptibility ranking to contamination.

We routinely monitor for constituents in your drinking water according to Federal and State laws. *Maximum Contaminant Level Goal (MCLG)* - The "Goal"(MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

*Maximum Residual Disinfectant Level (MRDL)* - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control microbial contaminants.

*Maximum Residual Disinfectant Level Goal (MRDLG)* - The level of a drinking water disinfectant below which there is no known or expected risk of health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

*Parts per million (ppm) or Milligrams per liter (mg/l)* - one part per million corresponds to one minute in two years or a single penny in \$10,000.

*Parts per billion (ppb) or Micrograms per liter* - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

We have learned through our monitoring and testing that some constituents have been detected, however, the EPA has determined that your water IS SAFE at these levels.

We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

#### Significant Deficiencies

During a sanitary survey conducted on 11/10/10 the Mississippi State Department of Health cited the following deficiency:

1.) Inadequate security measures

Corrective actions: The fencing surrounding the wells has been repaired. All deficiencies are scheduled to be completed by 11/29/10.

2.) Inadequate internal cleaning/maintenance of storage tanks

Corrective actions: An inspection had been performed and the deficiencies noted in the tank inspection are to be addressed within the Bilateral Compliance Agreement with the Mississippi State Department of Health. All deficiencies are scheduled to be completed by 8/31/2012.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children.
