(1) Total Coliform. Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. Coliforms were found in more samples than allowed and this was a warning of potential problems.

**Monitoring and Reporting of Compliance Data Violations:**

We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During September 2011, we tested positive for a total coliform bacteriological sample(s). The law requires that valid source water samples must be pulled within 24 hours when notified of a Total Coliform positive bacteriological sample. On September 15, 2011, we collected the source water samples in a timely manner, but due to a clerical error our system did not receive credit for the source water sample for the Ground Water Rule.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. 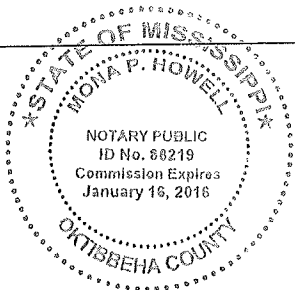
