Our water source consists of two wells that draw from the Lower Wilcox Aquifer.

A source water assessment has been completed for the water supply to determine the overall susceptibility of its drinking water to identify potential sources of contamination.. The water supply for Beulah Hubbard Water Association received a lower to moderate susceptibility ranking to contamination.

We're pleased to report that our drinking water meets all federal and state requirements.

(1) Total Coliform. Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. Coliforms were found in more samples than allowed and this was a warning of potential problems. The violation occurred December, 2011. It was resolved. For each detect of total coliform, additional samples were collected at the sites where total coliform was detected, upstream of each site and downstream of each site. Results showed all samples free of total coliform; however, it was noted that the chlorine residual in this area was lower than usual. The amount of chlorine was increased to insure an adequate chlorine residual was maintained.
