In accordance with the Radionuclides Rule, all community public water supplies were required to sample quarterly for radionuclides beginning January 2007 – December 2007. Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Mississippi State Department of Health Radiological health laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice. Although this was not the result of inaction by the public water supply, MSDH was required to issue a violation. This is to notify you that as of this date, your water system has not completed the monitoring requirements. The Bureau of Public Water Supply has taken action to ensure that your water system be returned to compliance by March 31, 2013. In accordance with the Safe Drinking Water Act, all community public water supplies are required to sample regularly for radionuclides beginning January 2007. Under the act, your public water supply completed sampling by the scheduled deadline however, during an audit of the Mississippi State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice. Although this suspension of monitoring by the public water supply MSDH was required to issue a violation. This is to help you make a decision on the status of your water system. If not complete the monitoring requirements, the Director of Public Water Supply has been action to ensure that you have a water system that is in compliance by March 31, 2012.
