Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During July 2011, we tested positive for a total coliform bacteriological sample(s). The standard is that no more than 1 sample per month of our samples may do so. No bacteria were reported in the subsequent testing and further testing showed that the problem was resolved.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. 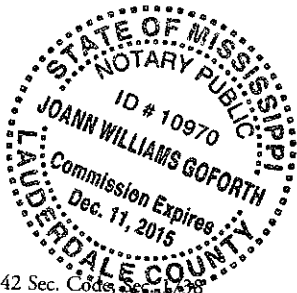
