Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. We did complete the monitoring requirements for bacteriological sampling that showed no coliform present. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

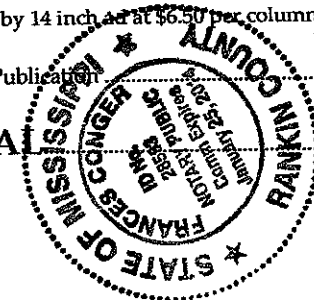

Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Department of Health Radiological health laboratory, the Environmental Protection Agency (EPA) suspended analyses and radiological compliance samples and results until further notice. Although this was not the result of inaction by the public water supply, the Bureau of Public Water Supply has taken action to ensure that your water system be returned to compliance by March 31, 2008.
