IS MY WATER SAFE?

Last year, as in years past, your tap water met all U.S. Environmental Protection Agency (EPA) and state drinking water health standards. Yokena-Jeff Davis Water District, Inc. vigilantly safeguards its water supply and once again we are proud to report that our system has not violated a maximum contaminant level or any other water quality standard.

DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. WHERE DOES MY WATER COME FROM?

Yokena-Jeff Davis Water District, Inc. purchases all of its water from the City of Vicksburg. The City of Vicksburg is a groundwater system whose water source is the Mississippi River Alluvial Aquifer.

Yokena-Jeff Davis Water District, Inc. would like to encourage everyone to attend the Annual Meeting which is held the second Monday in March. This will give customers the opportunity to ask questions and see what is taking place in our district.

WATER QUALITY DATA TABLE

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Yokena-Jeff Davis Water District, Inc. is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. To comply with the "Regulation Governing Fluoridation of Community Water Supplies", our system is required to report certain results pertaining to fluoridation of our water system. The number of months in the previous calendar year that average fluoride sample results were within the optimal range of 0.7-1.3 ppm was 8. The percentage of fluoride samples collected in the previous calendar year that was within the optimal range of 0.7-1.3 ppm was 67%.

Term	Definition
MCLG	MCLG: Maximum Contaminant Level Goal: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
MCL	MCL: Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are not as close to the MCLGs as feasible using the best available treatment technology.
AL	AL: Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
