The wells for the Town of Drew have received moderate susceptibility rankings to contamination.

*Parts per million (ppm) or Milligrams per liter (mg/l)* - one part per million corresponds to one minute in two years or a single penny in \$10,000.

*Parts per billion (ppb) or Micrograms per liter* - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

#### Significant Deficiencies

During a sanitary survey conducted on 7/22/10 the Mississippi State Department of Health cited the following deficiency:

Inadequate internal cleaning/maintenance of storage tanks

Corrective actions: This system is currently under a Bilateral Compliance Agreement with the MSDH to correct this deficiency by 8/31/2012.
