**Annual Drinking Water Quality Report

This report is designed to inform you about the quality water and services we deliver to you every day. Your local water utility vigilantly safeguards its water supplies and once again we are proud to report that the Conehatta System has not violated a maximum contaminant level or any other water quality standard. January thru December 2012, your tap water met all U.S. Environmental Protection Agency (EPA) and state drinking water health standards. Our water comes from two wells that are over 1000 feet in depth and comes from a underground water source called Wilcox Aquifer. A copy of the EPA Source Water Assessment may be obtained from Becky Hall at the Choctaw Public Works by calling 601-650-1760. The Mississippi Band of Choctaw Indians (MBCI) Public Works Department is responsible for running four community water systems. This report is for the Federal and State Laws. If you would like to learn more about your water system or when the next scheduled utilities board meeting will be please call the water plant supervisor Travis Bryan or the utilities director Bill Gordon at the Choctaw Tribal Utilities office 601-650-1760.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Drinking water, including bottled water, may reasonable be expected to contain at least small amount of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, substances resulting from the presence of animals or from human activity.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The MBCI Public Works Department is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. MCLG	MCLG: Maximum Contaminant Level Goal: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
MCL	MCL: Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
TT	TT: Treatment Technique: A required process intended to reduce the level of a contaminant in drinking water.
AL	AL: Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system
Variances and Exemptions	Variances and Exemptions: State or EPA permission not to meet an MCL or a treatment technique under certain conditions.

volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.
