Our water source is from wells drawing from the Gordo Formation Aquifer.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Poplar Springs Water Association have received lower susceptibility rankings to contamination.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. *******April 1, 2013 MESSAGE FROM MSDH CONCERNING RADIOLOGICAL SAMPLING*******

In accordance with the Radionuclides Rule, all community public water supplies were required to sample quarterly for radionuclides beginning January 2007 – December 2007. Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Mississippi State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice. Although this was not the result of inaction by the public water supply, MSDH was required to issue a violation. This is to notify you that as of this date, your water system has completed the monitoring requirements and is now in compliance with the Radionuclides Rule. Immuno-compromised persons such as persons with cancer, undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. April 1, 2015 MESSAGE FROM MSDH CONCERNING RADIOLOGICAL SAMPLING
 In accordance with the Radon-222 Rule, all community public water supplies were required to sample quarterly for radon-222 beginning January 2007 - December 2007. Your public water supply completed sampling by the scheduled deadline; however, during the month of the Mississippi State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analysis and reporting of radiological compliance samples and results until further notice. Although the test and the result of action by the public water supply, MSDH was required to issue a violation. This is to notify you that as of this date, your water system has completed the monitoring requirement and is now in compliance with the Radon-222 Rule.
