Our water source is from wells drawing from the Miocene Series Aquifer.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Bogue Chitto Water Association, Inc. have received a moderate susceptibility ranking to contamination.

We routinely monitor for constituents in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that we detected during for the period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2012. In cases where monitoring wasn't required in 2012, the table reflects the most recent results. 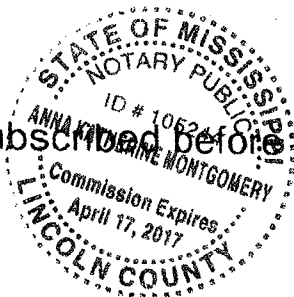
