The wells for the Janice Water Association have received a lower susceptibility ranking to contamination.

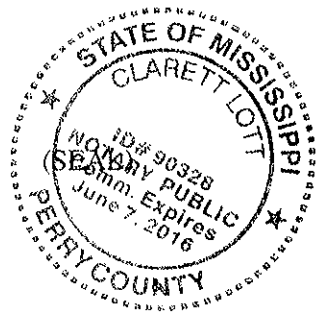
