In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

During a sanitary survey conducted on 11/29/11, the Mississippi State Department of Health cited the following significant deficiency(s):
Inadequate internal cleaning/maintenance of storage tanks.

Corrective Action: This system is currently under a Bilateral Compliance Agreement with the MSDH to correct this deficiency by 3/20/2013.

Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. 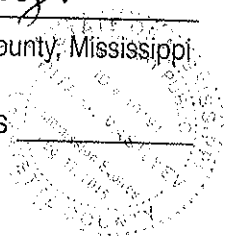
