We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. As you can see in the table below, our system had no contaminated violations. We're proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some constituents have been detected however, the EPA has determined that our water IS SAFE at these levels.

*******A MESSAGE FROM MSDH CONCERNING RADIOLOGICAL SAMPLING*******

In accordance with the Radionuclides Rule, all community public water supplied were required to sample quarterly of radionuclides beginning January 2007- December 2007. Your public water supply completed sampling by the scheduled deadline; however,, during an audit of the Mississippi State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice.

Although this was not the results of inaction by the public water supply, MSDH was required to issue a violation.
