SIGNIFICANT DEFICIENCIES

During a sanitary survey conducted on 1/31/12, the Mississippi State Department of Health cited to following significant deficiency(s):

- 1) Well near source of fecal contamination (ex. Septic system, sewer lines)
- 2) Lack of redundant mechanical components where treatment is required.

Corrective Actions:

- 1) The system has abandoned the well through the MSDH well abandonment program and is awaiting the final paperwork. It is anticipated we will be returned to compliance by June 1, 2013.
- 2) The system has installed another chlorine system and is awaiting the final paperwork from MSDH. It is anticipated we will be returned to compliance by June 1, 2013.

*******APRIL 1, 2013 MESSAGE FROM MSDH CONCERNING RADIOLOGICAL SAMPLING*******

In accordance with the Radionuclides Rule, all community public water supplies were required to sample quarterly for radionuclides beginning January 2007 - December 2007. Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Mississippi State Department of Health Radiological Health Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice. Although this was not the result of inaction by the public water supply, MSDH was required to issue a violation.
