

Our water source is from wells drawing from the Catahoula Formation, Cockfield Formation and Miocene System Aquifers.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Reedtown Water Association have received lower to moderate susceptibility rankings to contamination.

Disinfection By-Products:

(81) Haloacetic Acids (HAA5). Some people who drink water containing bromate in excess of the MCL over many years may have an increased risk of cancer
(82) Total Trihalomethanes (TTHMs). Some people who drink water containing trihalomethanes in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous systems, and may have an increased risk of getting cancer.

Our systems violated a drinking water standard. We exceeded the MCL for Disinfection Byproducts in all quarters of 2012. The standard for Trihalomethanes (TTHM) is .080 mg/l. The standard for Haloacetic Acids (HAA5) is .060mg/l. On System # 110028 our TTHMs ranged from 88-156 and our HAA5s ranged from 141 – 227. On System # 250007 our TTHMs ranged from 286-352 and our HAA5s ranged from 134 – 157. We are working with the MSDH to evaluate the water supply and researching options to correct the problem.

We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Significant Deficiency – System # 250021

During a sanitary survey conducted on 8/24/2010, the Mississippi State Department of Health cited the following significant deficiency:

Inadequate pump capacity

Corrective actions: This system has entered into a Bilateral Compliance Agreement with the Mississippi State Department of Health to correct this deficiency by 1/10/2014.
