Our water source is from wells drawing from the Catahoula Formation Aquifer.

We want our valued customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the first Tuesday of each month at 6:00 PM at the Fayette City Hall.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Town of Fayette have received a lower to moderate susceptibility ranking to contamination.

We routinely monitor for constituents in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that we detected during for the period of January 1st to December 31st, 2013. In cases where monitoring wasn't required in 2013, the table reflects the most recent results. Microbiological Contaminants:

(1) Total Coliform. Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. Coliforms were found in more samples than allowed and this was a warning of potential problems.

We routinely monitor for the presence of drinking water contaminants. We took 2 samples for coliform bacteria during July 2014. Both of the samples showed the presence of coliform bacteria. The standard is that no more than 1 sample per month may do so. We did not find any bacteria in our subsequent testing and further testing shows that this problem has been resolved.

We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

Significant Deficiencies

During a sanitary survey conducted on 5/17/10, the Mississippi State Department of Health cited the following deficiency:
Inadequate internal cleaning/maintenance of storage tanks

Corrective actions: MSDH is currently working with this system to return them to compliance since the expiration of the compliance deadline. It is anticipated we will be returned to compliance by December 31, 2014.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our Water Association is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
