Our water source is from two wells drawing from the Lower Catahoula Aquifer.

The source water assessment has been completed for our public water system to determine overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information is available for viewing upon request. Our wells ranked moderate for susceptibility to contamination.

Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Canebroke Utilities Association, Inc. is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking.
