A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the South Holmes Water Association have received moderate susceptibility rankings to contamination.

We routinely monitor for constituents in your drinking water according to Federal and State laws. In cases where monitoring wasn't required in 2013, the table reflects the most recent results. Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

During a sanitary survey conducted on 5/31/2012, the Mississippi State Department of Health cited the following significant deficiency(s).
Inadequate internal cleaning/maintenance of storage tanks.

Corrective actions: MSDH is currently working with this system to return them to compliance since the expiration of the compliance deadline. It is anticipated we will be returned to compliance by December 31, 2014.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.
