Is my water safe?

We are pleased to present this year's Annual Water Quality Report (Consumer Confidence Report) as required by the Safe Drinking Water Act (SDWA). This report is designed to provide details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. This report is a snapshot of last year's water quality. We are committed to providing you with information because informed customers are our best allies. Last year, we conducted tests for over 80 contaminants. We only detected 8 of those contaminants, and found only 2 at a level higher than the EPA allows. As we informed you at the time, our water temporarily exceeded drinking water standards. (For more information see the section labeled Violations at the end of the report.)

Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Water Drinking Hotline (800-426-4791).

Where does my water come from?

We're pleased to provide you with this year's Annual Water Quality Report. We want to keep you informed about the excellent water and services we have delivered to you over the past year. Our goal is and always has been to provide you a safe and dependable supply of drinking water. Our water source is drawn from the Meridian-Upper Wilcox Aquifer.

Source water assessment and its availability

The source water assessment has been completed for our public water to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. The general susceptibility rankings assigned to the well of this system is provided immediately below. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request.

We are pleased to report that our drinking water meets all federal and state requirements.

Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. As your water travels over land and underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents doesn't necessarily pose a health risk.

Description of Water Treatment Process

Your water is treated by disinfection. Disinfection involves the addition of chlorine or other disinfectant to kill dangerous bacteria and microorganisms that may be in the water. Disinfection is considered to be one of the major public health advances of the 20th century.

Significant Deficiencies

Deficiencies-During a sanitary survey on 08/23/2012, the Mississippi Department of Health cited the following Deficiencies: Inadequate internal cleaning/maintenance of storage tanks, Lack of redundant mechanical components where treatment is required, No approved Emergency Response Plan or Vulnerability Analysis, and Inadequate security measures. Corrective Action: MSDH is currently working with this system to return them to compliance since the compliance deadline it is anticipated we will be returned to compliance by December 31, 2014.

Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Town of Doddsville is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Violations and Exceedances

Haloacetic Acids (HAA5)

Some people who drink water containing haloacetic acids in excess of the MCL over many years may have an increased risk of getting cancer. In 2013 our system was cited for violating the Mississippi Safe Drinking Water Act by exceeding the maximum contaminant level requirement for Disinfection Byproducts of the total haloacetic acids (HAA5) in our drinking water. The system has since started an extensive flushing program to prevent this from happening in the future. Chlorine can get stagnant in the dead-end lines and cause these numbers to be higher than normal as well as injecting too much chlorine into our drinking water.

TTHMs [Total Trihalomethanes]

Some people who drink water containing trihalomethanes in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous system, and may have an increased risk of getting cancer. This past year our system was cited for violating the Mississippi Safe Drinking Water Act by exceeding the maximum contaminant level requirements for Disinfection Byproduct of the total TTHM in our drinking water. The system has since started an extensive flushing program to prevent this from happening in the future. Chlorine can get stagnant in the dead-end lines and cause these numbers to be higher than normal as well as injecting too much chlorine into our drinking water.
