A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Columbus Light and Water have received a moderate ranking in terms of susceptibility to contamination.

Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.
