A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Holmes Interstate Utility District have received lower to moderate susceptibility rankings to contamination.

Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.
