

The wells for the Town of Meadville have received a moderate susceptibility ranking to contamination.

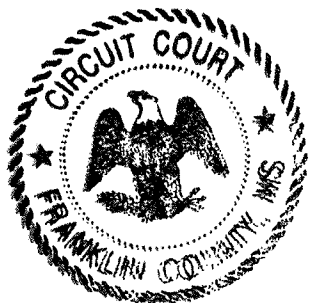
