

A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Town of Taylorsville have received a moderate susceptibility ranking to contamination.

In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

On January 21, 2014 the MSDH cited our system with a significant deficiency of "Inadequate internal cleaning/maintenance of storage tanks." The downtown water tank was built in 1939 and was renovated in the late 1980s. The initial plan was to demolish the tank but several citizens wanted to restore it for historical purposes. We have received a Mississippi Small Municipalities Limited Population Counties grant to refurbish the tank. We expect to have this completed by September 30, 2017.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. 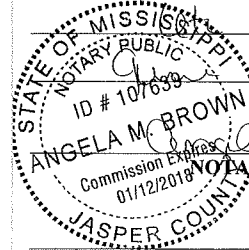
