We routinely monitor for the presence of drinking water contaminants. Testing results we received show that our system exceeded the standard, or maximum contaminant level (MCL), for Disinfection Byproducts. The standard for Trihalomethanes (TTHM) is .080mg/l. Our system exceeded this MCL in all four quarters of 2015.

We are required to monitor your drinking water for specific constituents on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.
