Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. 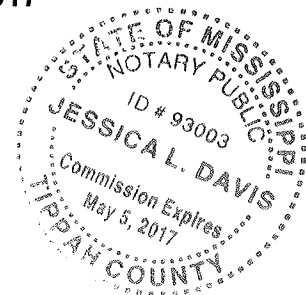
