Our water source is from 2 wells using water from the Miocene Aquifer.

The general susceptibility rankings assigned to each well of this system are provided immediately below. A report containing detailed information of how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Magnolia Rural Water Association have received a moderate susceptibility ranking to contamination.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk.
