

As you can see by the table, this system had no violations. While you had your drinking water system, you should follow all Federal and State requirements. We have been through our monitoring and testing of our conditions, have been selected to be on the EPA file, determined that your water is SAFE at the present.

We are required to monitor your drinking water for specific contaminants on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. We do complete this monitoring to ensure compliance with monitoring requirements for bottled water, and to ensure that your water is safe for consumption. This is done to ensure appropriate monitoring requirements. MS24 has no other systems of any drinking water prior to the end of the compliance period.

If present, elevated levels of lead, chromium, arsenic, and other contaminants, especially for pregnant women and young children.
