

The wells for the Highpoint Water Association have received moderate rankings in terms of susceptibility to contamination.

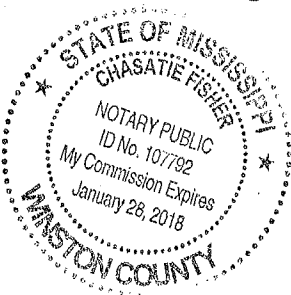
