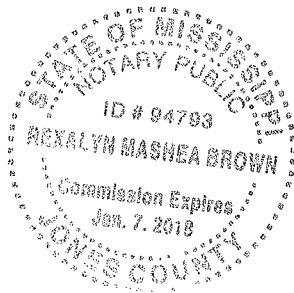

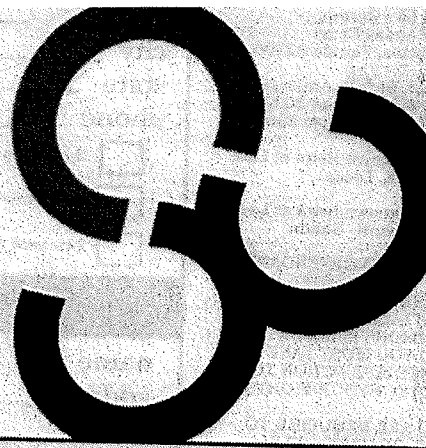

The House also passed a budget for the Attorney General's office, in the form of House Bill 1, and allotted \$175 million to State Aid Road money. The House also they could spend their Senate Bill 2001, which deposits state agency special funds into the state general fund.
