We found coliform indicating the need to look for potential problems in water treatment or distribution. When this occurs, we are required to conduct assessment(s) to identify problems and to correct any problems that were found during these assessments.

During the past year we were required to conduct and completed 1 (one) Level 1 assessment in addition, we were required to take and completed 1 (one) corrective action.

Our system received a major monitoring violation for sample was rejected due to air bubbles in sample for the period of 1/01/2016 - 12/31/2016.



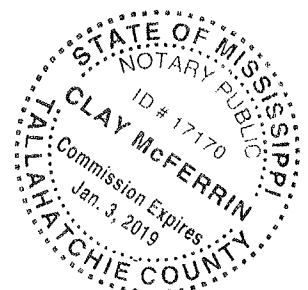
