Our wells draw from the Meridian Upper Wilcox aquifer.

A Source Water Assessment has been completed for our public water system to determine the overall susceptibility of the drinking water supply and to identify potential sources of contamination. The general susceptibility rankings assigned to each well of this system are provided immediately below. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water supply and is available upon request. The wells for The Town of Doddsville have received moderate to higher susceptibility rankings to contamination.

From 07/01/2016 – 09/30/2016 we did not monitor for Chlorine and E.Coli and therefore cannot be sure of the quality of your drinking water during that time. A public notice regarding this violation has already been provided to each customer.

We are required to monitor your drinking water for specific contaminants monthly. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. To ensure systems complete all monitoring requirements, MSDH now notifies systems of any samples prior to the end of the monitoring period.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of Doddsville is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your

water tested. MONITORING AND REPORTING OF COMPLIANCE DATA VIOLATIONS

During a sanitary survey conducted on 8/23/2012, the Mississippi State Department of Health cited the following significant deficiency(s):

- No approved emergency response plan or vulnerability analysis.
- Lack of redundant mechanical components where treatment is required.
- Inadequate security measures
- Inadequate internal cleaning/ maintenance of storage tanks

MSDH is currently working with the Town of Doddsville to return them to compliance since the expiration of the compliance deadline.
