



2016-2017 Influenza Report Week 08 Feb. 19 – Feb. 25, 2017

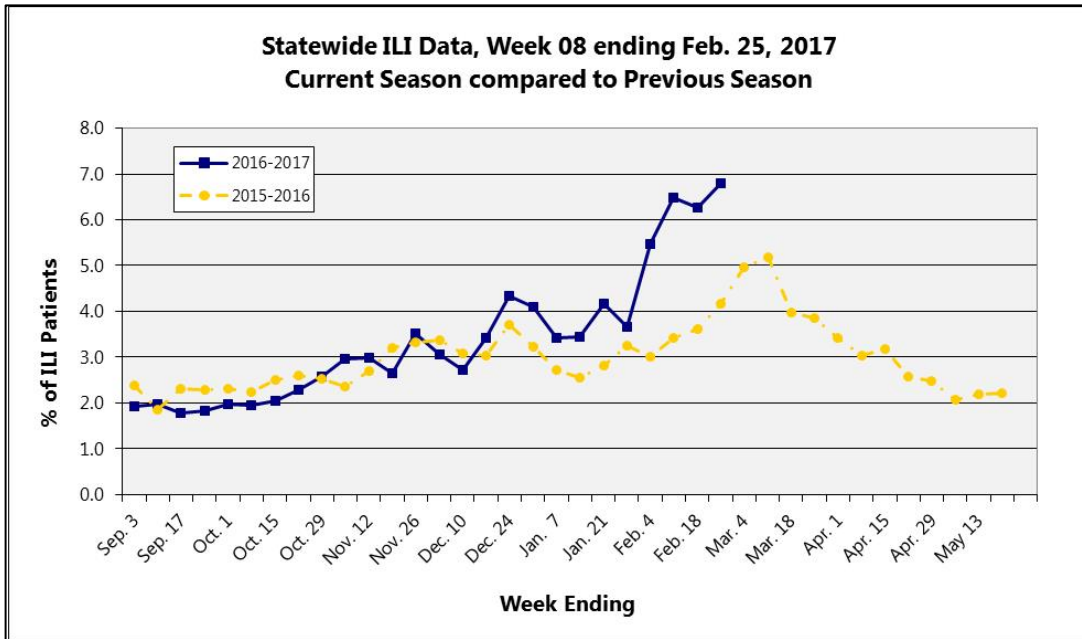
About our flu activity reporting

MSDH relies upon selected sentinel health practitioners across the state to report the percentage of total patient visits consistent with an influenza-like illness (ILI: fever of 100°F or higher AND cough and/or sore throat). Also, providers are supplied with specimen collection kits. Samples are submitted to the Mississippi Public Health Laboratory for influenza PCR testing. Reports are used to estimate the state's ILI rate and the magnitude of the state's influenza activity. Reports represent only the distribution of flu in the state, not an actual count of all flu cases statewide. **Information is provisional only and may change depending on additional reporting from sentinel providers.**

State ILI Surveillance



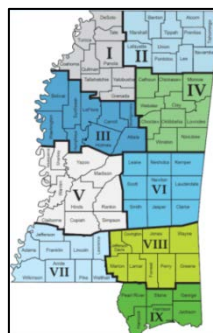
During week **08** (02/19/17 - 02/25/17), the state ILI rate (**6.8%**) **increased slightly** from the previous week (**6.3%**), but was **higher** than this time last year (**4.2%**).

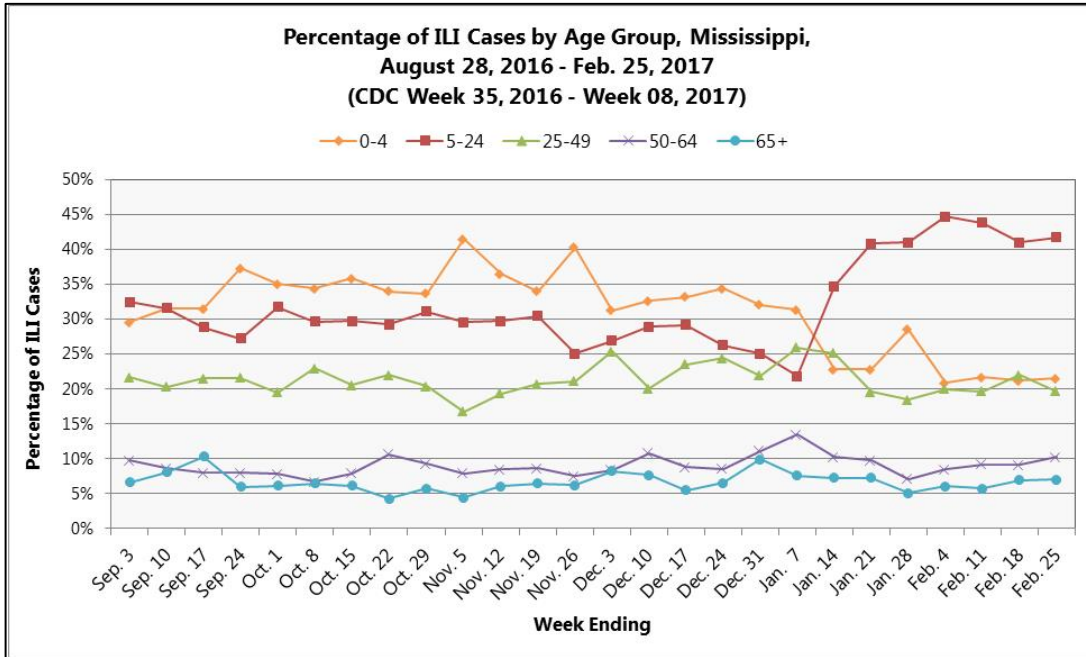

During week **08**, **four** districts (1, 2, 3, and 5) had an increase in ILI activity, while **one** district (4) had a decrease. **Four** districts (6, 7, 8, and 9) remained about the same. *Information is provisional only and may change depending on additional reporting from sentinel providers.* | Table 2



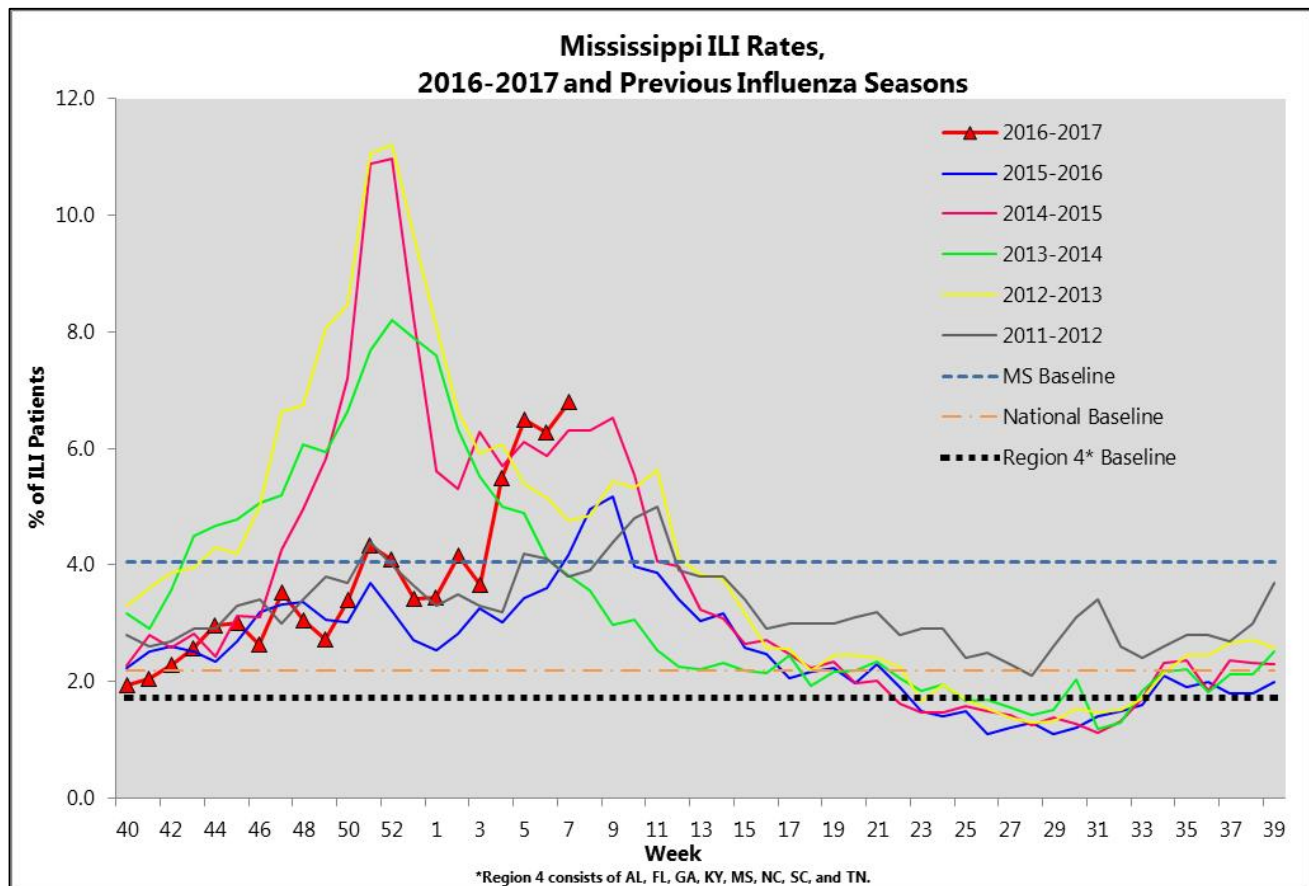

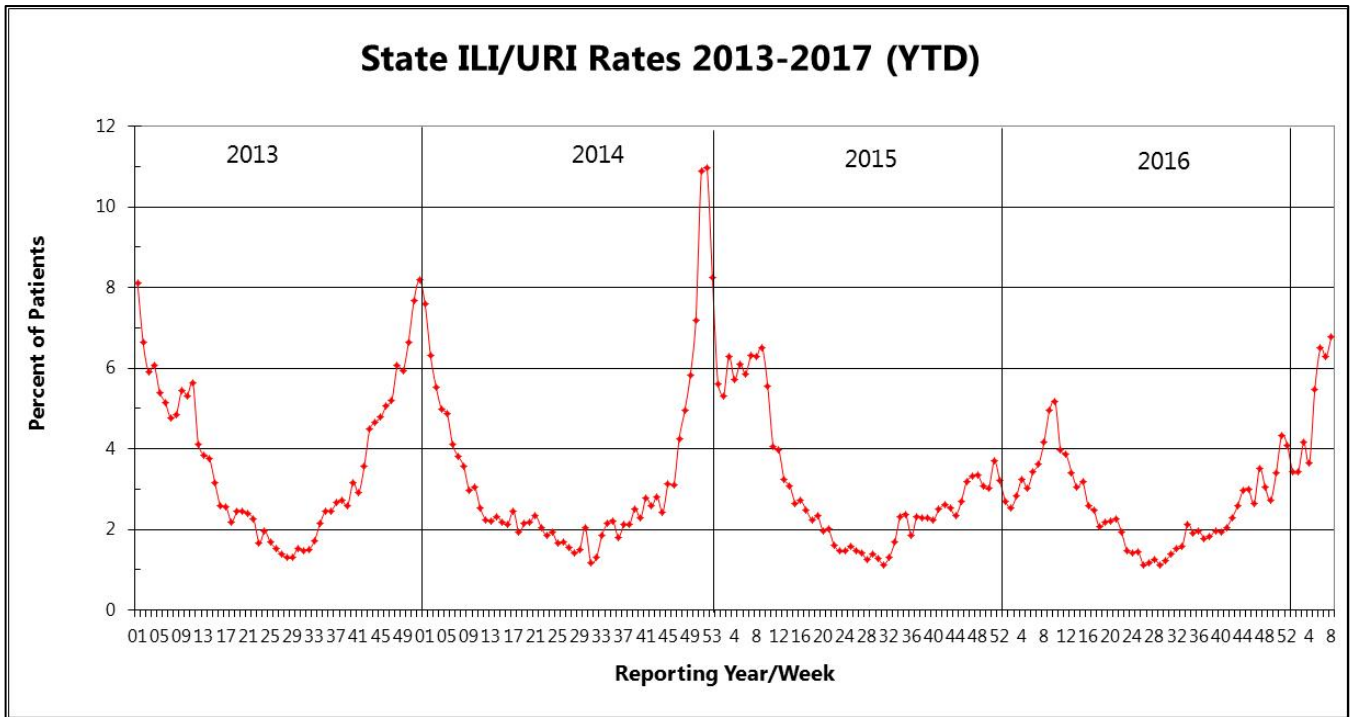

The 2016-17 state ILI rate was **above** the national, Region 4, and state baselines for week **08**. | [Figure 3](#)

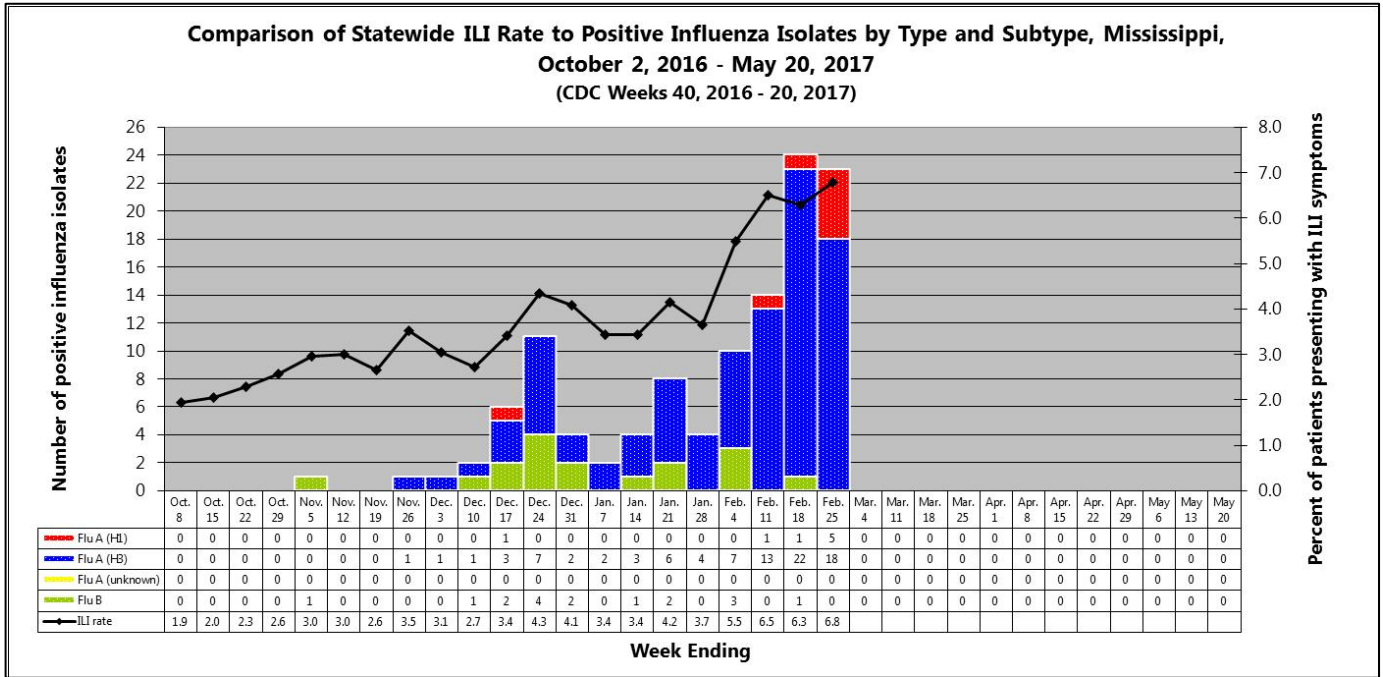


Mississippi ILI Rates 2013-2017 | [Figure 4](#)



Flu Testing Reports

From week **40** (week ending Oct. 8th) through week **08** (week ending Feb. 25th), **115** laboratory confirmed influenza samples were identified by the MSDH Public Health Laboratory. Ninety (78%) samples were identified as influenza A (H3), 17 (15%) were identified as influenza B, and eight (7%) were identified as influenza A (H1). | [Figure 5](#)



The influenza cases were identified from the following counties: Alcorn (3), Attala (1), Coahoma (8), Copiah (4), Covington (1), DeSoto (1), Forrest (2), George (3), Harrison (2), Hinds (4), Holmes (2), Jones (1), Lafayette (3), Lauderdale (3), Lawrence (1), Lee (4), Leflore (1), Lincoln (12), Lowndes (8), Madison (2), Marion (2), Marshall (4), Monroe (3), Neshoba (4), Newton (2), Oktibbeha (10), Pearl River (2), Pike (3), Pontotoc (1), Rankin (1), Sharkey (1), Tate (2), Tippah (4), Warren (2), Washington (4), Webster (2), and Winston (2).

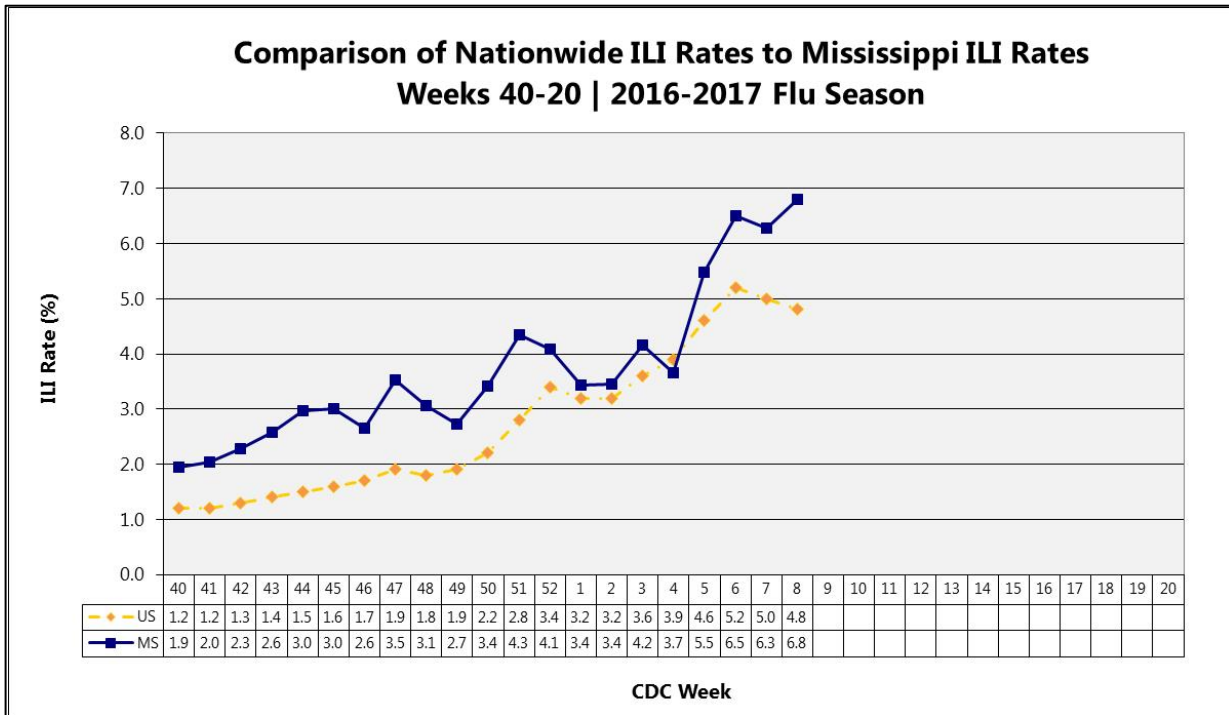
National and Mississippi Pediatric Mortality Surveillance

Nationally, **six** influenza-associated pediatric deaths were reported to CDC during week **08**. Two deaths were associated with an influenza A (H3) virus and occurred during weeks 07 and 08 (weeks ending February 18th and February 25th, respectively). One death was associated with an influenza A (H1N1)pdm09 virus and occurred during week 06 (week ending February 11th). Two deaths were associated with an influenza A virus for which no subtyping was performed and occurred during weeks 06 and 08. One death was associated with an influenza B virus and occurred during week 07. **40** influenza-associated pediatric deaths have been reported during the 2016-2017 season.

Mississippi has had **one** influenza-associated pediatric death reported during this influenza season. For additional information on influenza-associated pediatric deaths, please refer to the [CDC's FluView](#).

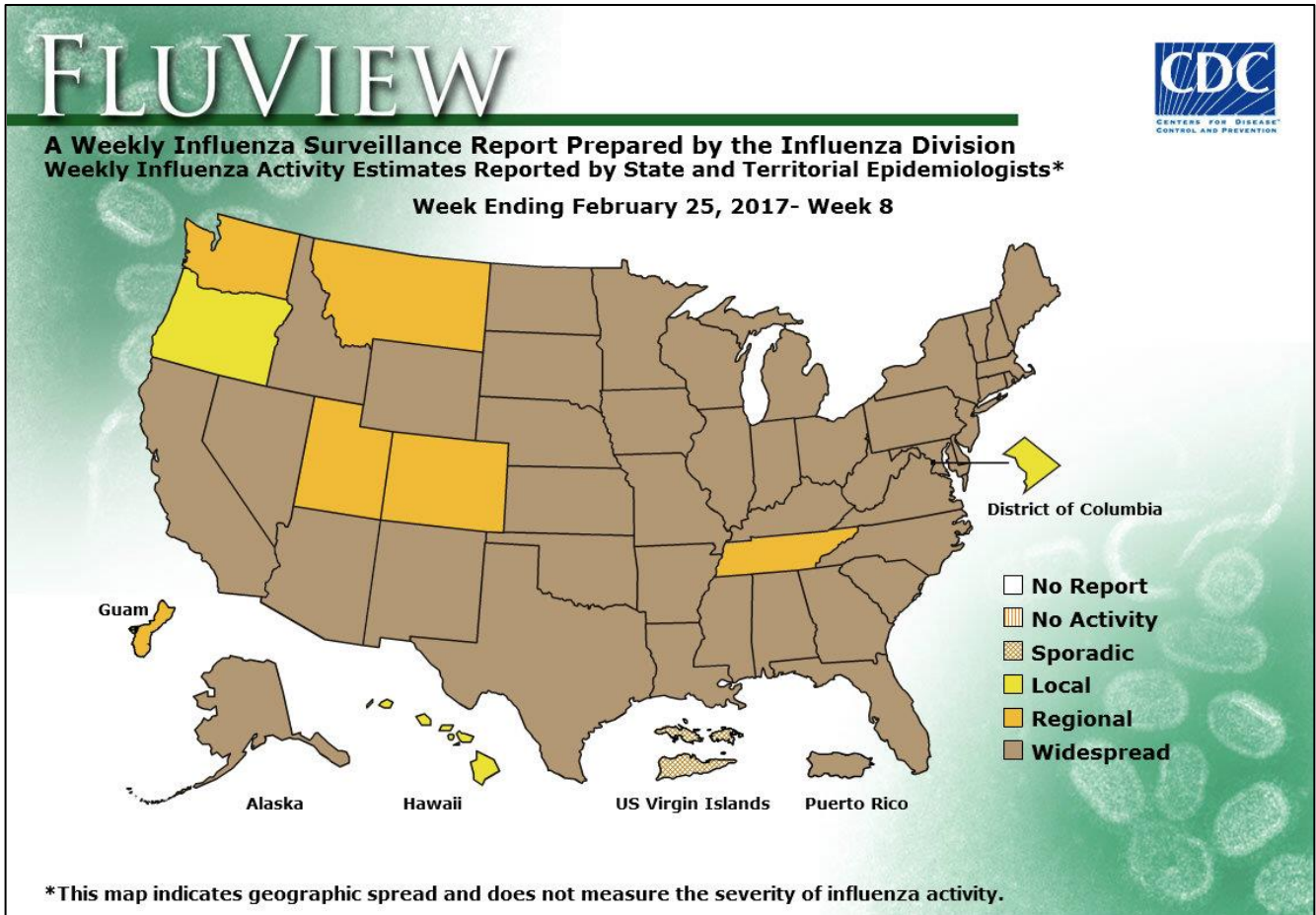
National ILI Surveillance

Level of Flu Activity	Definition
No Activity	Overall clinical activity remains low and there are no lab confirmed cases.
Sporadic	Isolated cases of lab confirmed influenza in the state; ILI activity is not increased <u>OR</u> A lab-confirmed outbreak in a single institution in the state; ILI activity is not increased.
Local	Increased ILI within a single region AND recent (within the past 3 weeks) laboratory evidence of influenza in that region. ILI activity in other regions is not increased <u>OR</u> two of more institutional outbreaks (ILI or lab confirmed) within a single region AND recent (within the past 3 weeks) lab confirmed influenza in that region. Other regions do not have increased ILI and virus activity is no greater than sporadic in those regions
Regional	Increased ILI in at least 2 regions but fewer than half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the affected regions <u>OR</u> Institutional outbreaks (ILI or lab confirmed) in at least 2 regions but fewer than half of the regions AND recent lab confirmed influenza in the affected regions.
Widespread	Increased ILI and/or institutional outbreaks (ILI or lab confirmed) in at least half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the state.

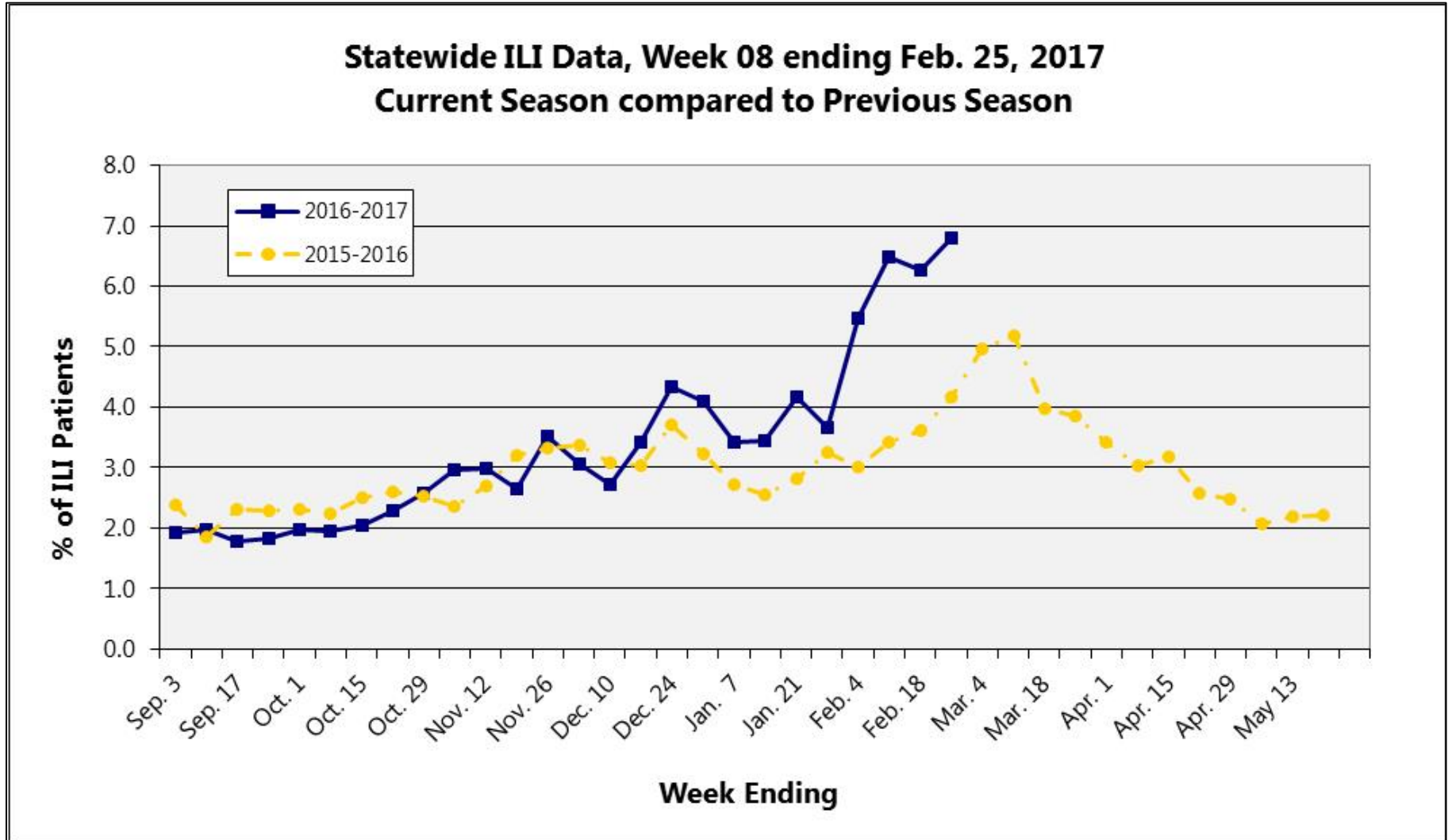

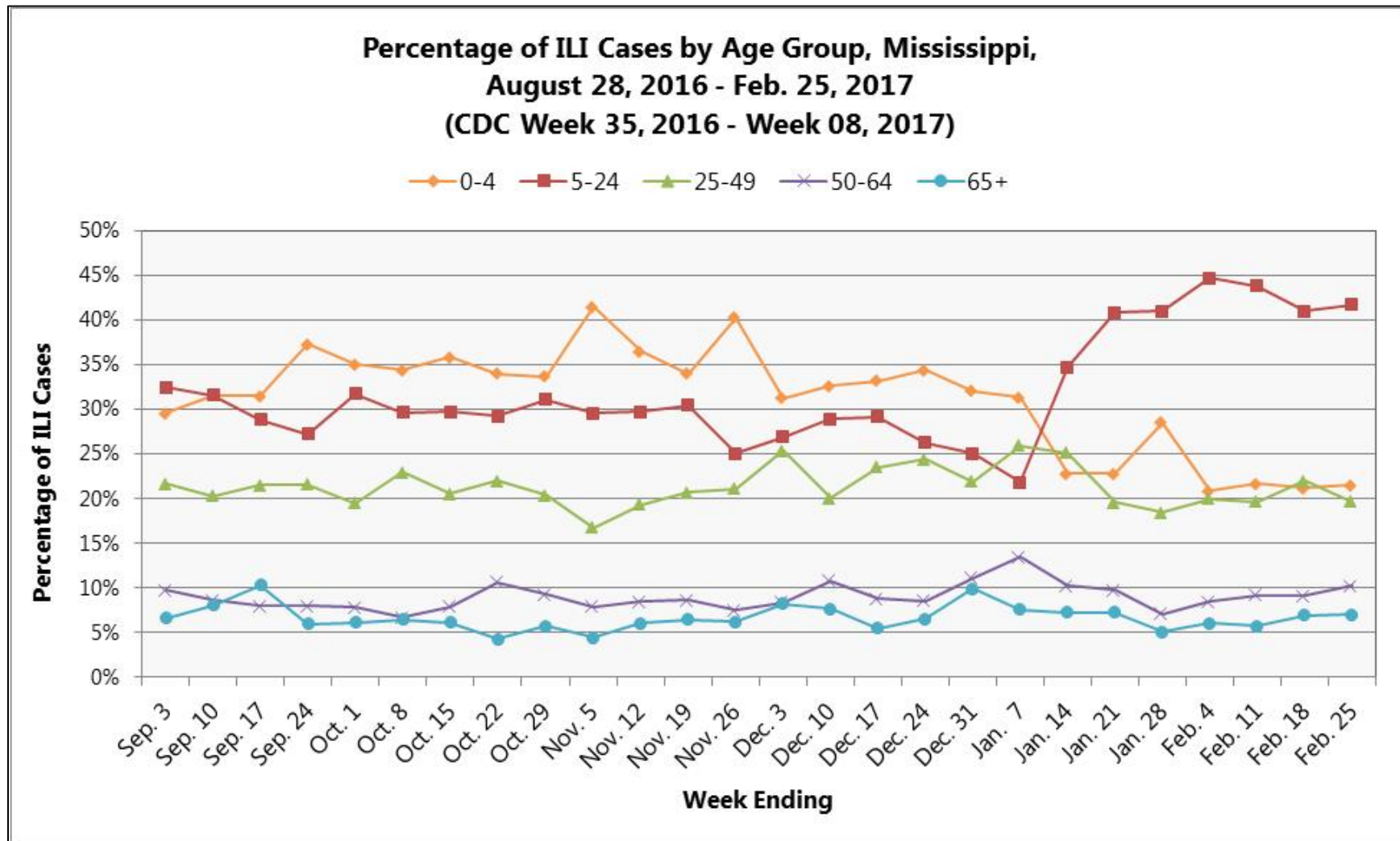

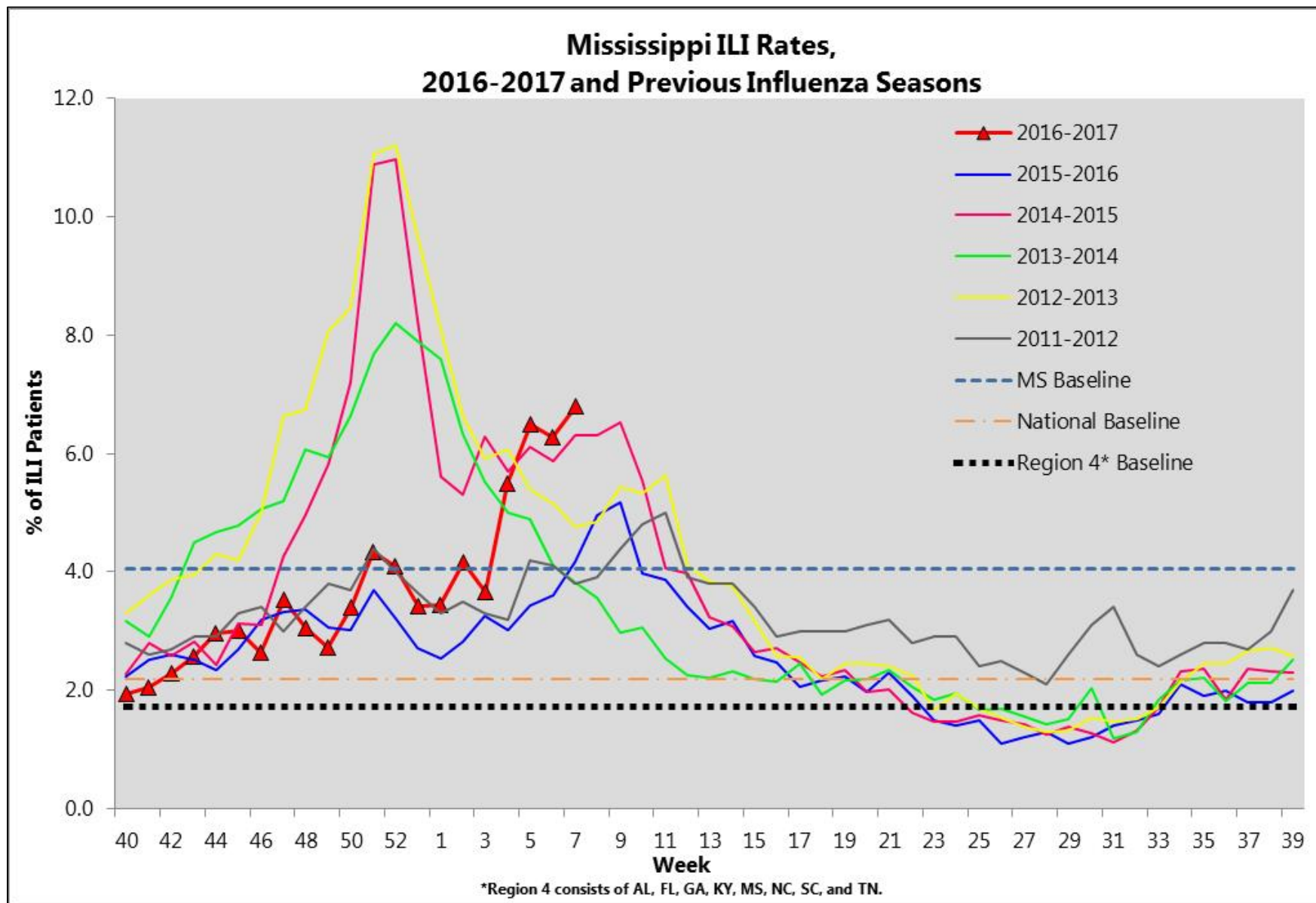

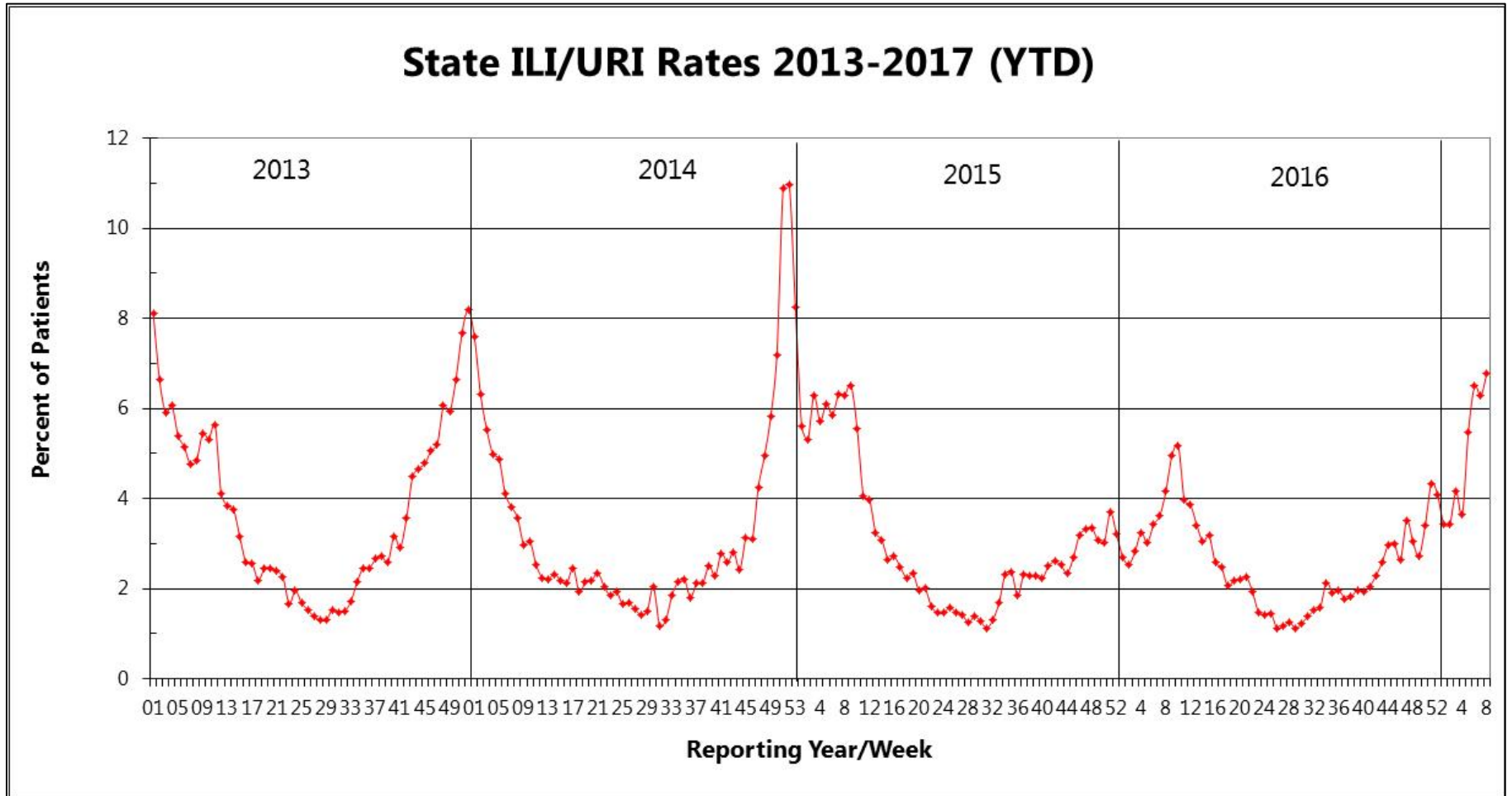

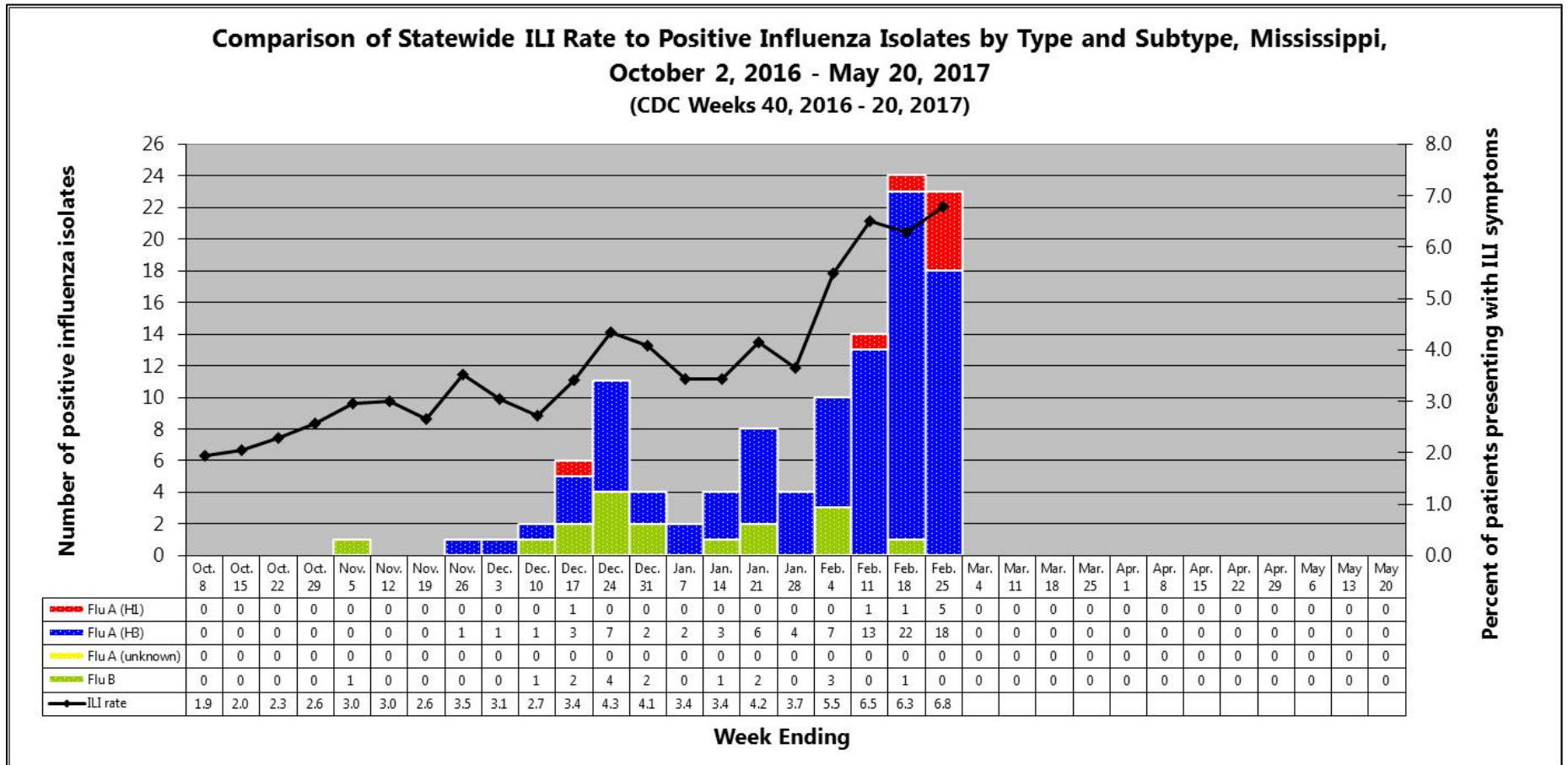

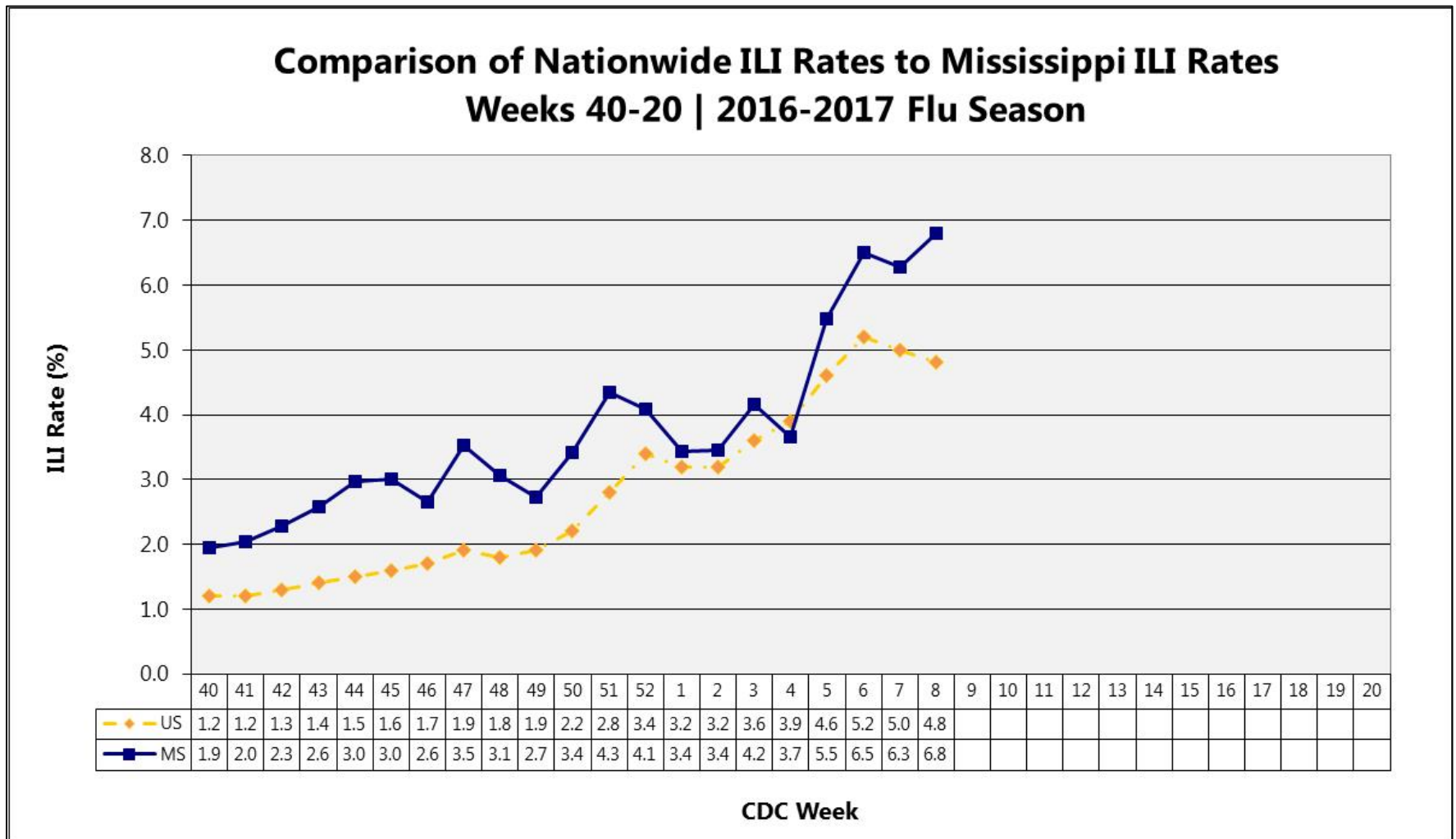
