EMS Medical Director Update: (Bob Galli, MD)

- Mississippi is first state to have a statewide regional trauma plan that's "doing really well".

- Mississippi is very close to implementing an organized training program for EMS medical directors throughout the state. It is an online training course.
- MDTQA restructure: structuring committee to include Mississippi four Congressional Districts represented with two people in each district. All will be board certified emergency physicians. Have six of eight position allocated. Seeking other nominations.

MTAC Update: (Pete Avara, MD)

- MTAC has identified activation criteria for Alpha and Bravo trauma calls for the state.
- MTAC has revised the state plan destination guideline protocol so all will have same system of identifying trauma patients as Alpha and Bravo and what facility to transport to.
