1.	Approval of August 3, 2024 minutes	A motion was made by Dr. House to approve the minutes of the May 3, 2024 meeting. Dr. Grillis seconded the motion. The minutes were approved.
2.	Renewal Update	Ms. Saleem informed the Council that after the renewal ended on June 30, 2024, the current active licensees for SLP is 1522, and AUD is 200. Licensees are still able to renew online until September 30, 2024, and after October 1, 2024, they will have to mail renewals into the office.
3.	Compact Update	Ms. Wang informed the Council that there was an ASLP-IC Special Commission meeting on July 1, 2024, and that they stated the compacts for SLP/A, OT, and Counseling are looking to use a combined database respective to each profession, and that the pricing is currently about \$500,000 each. They are still working on it, and that the database for ASLP-IC is looking to be late 2024 or early 2025 to start up. Ms. Wang also informed the Council that there is an annual business meeting of the ASLP-IC in September, and Ms. Wang will be attending in person as the state's delegate.
