



## MISSISSIPPI STATE DEPARTMENT OF HEALTH

**About the Position:** The Office of Women's Health, Jackson State University Mississippi Delta Center of Excellence in Maternal Health Program is seeking to fill one (1) part-time Nurse Case Manager II contract position. No more than 25 hours per week are anticipated for this position. This position will functionally serve as a Nurse Home Visitor for the program. The Nurse will provide face-to-face home visiting support services to post-partum women in 1 county (Scott). The Nurse will support the development of policies, procedures, workflows, forms, documentation standards, and referral communication channels for the program. S/he/they will provide training to medical providers and community stakeholders on the program's referral process and universal educational messaging regarding postpartum health and well-being. The Nurse will serve as the initial point of contact for all patients upon referral from the discharging hospital or other referral sources at post-birth discharge. S/he/they will establish contact, consent, and complete the initial postpartum home visit with all patients, completing all required biophysical and other nursing assessments. S/he/they will provide training to and support other staff in providing ongoing direct services to program participants. Lead point of contact with the OB/Gyn and/or PCP/medical home to address ongoing postpartum risk management of high-risk patients. Conduct biometric assessments at the home visits to include blood pressure, weight, postpartum hemorrhage/infection assessments, wound and temperature checks, and assistance with medical treatments.

**Supervision:** Reports to the DCOE Program Manager. Has no direct reports.

**What You'll Need to be Successful:** Successful employees need to be bilingual in English and Spanish, have good customer service skills and be able to communicate effectively. They should be able to work autonomously and in a team. The employee should have good time management and organizational skills. The employee should be culturally sensitive and exhibit problem solving and conflict resolution skills. To be successful the employee should have a passion for caring for and educating families. Need to have knowledge of community resources and use that knowledge effectively to assist clients and/or patients as needed. Must be able to travel across a 1 county catchment area daily and 4 county catchment area (Washington, Bolivar, Carroll, and Humphreys counties) as needed and provide services in the homes of participants, and exercise independent judgment.

**Salary Range:** \$28.60 – \$35.17 an hour (depending on experience)

**Location:** Base is TBD. Must be able to travel across Scott county and to other service counties as needed.

**Qualifications:** State license as a Registered Nurse and 5+ years relevant work experience
