 - Report writer
 - ICD 9 and ICD 10 codes
- The trauma registry sub-committee is going to work on data of what is going on in Mississippi in trauma to take to MTAC next meeting. These fields include: ED length of stay, mortality rates for Alphas, and TRISS report for Alphas.
